#### BACKGROUND

The ongoing crisis in Gaza represents one of the gravest humanitarian and legal challenges of our time. The devastation, displacement, and mass suffering inflicted upon Palestinians demand urgent and uncompromising global attention. In the face of ongoing atrocities, the international legal framework, particularly the **Genocide Convention**, compels states and institutions to act—yet, the response has largely been marked by inaction, impunity, and moral failure.

Against this backdrop, the **Palestinian Return Centre (PRC)** is convening a landmark conference, Naming Genocide: The Global Responsibility for Gaza, on **February 22, 2025, in London**. This conference is not just a platform for discussion; it is an urgent call to action. It seeks to interrogate the legal, political, and moral obligations of the international community in recognizing and responding to genocide and to explore the role of advocacy, media, and solidarity in countering erasure and impunity.

This conference brings together some of the world's leading experts in **international law, human rights, diplomacy, and media** to dissect the current reality in Gaza, challenge prevailing narratives, and propose actionable strategies to uphold justice and accountability.



#### VISION

At a time when state violence is met with diplomatic complacency, and when the systematic destruction of a people is normalized under the pretext of self-defense, we seek to **shift the global discourse**, **redefine legal responsibility**, **and mobilize a serious**, **sustained response to genocide**.

The **vision** of this conference is threefold:

- 1. To name genocide for what it is.

  The legal determination of genocide is a matter of historical and moral consequence. This conference aims to lay bare the patterns of mass atrocities against Palestinians and the urgent need to frame them within their proper legal context.
- 2. To mobilize international mechanisms for accountability. By bringing together legal scholars, advocates, and policymakers, we seek to identify viable avenues for pursuing justice, whether through the International Court of Justice (ICJ), International Criminal Court (ICC), universal jurisdiction, or other forms of legal redress.
- 3. To center Palestinian voices in defining their struggle.

  This conference will resist the erasure of Palestinian agency and experience, ensuring that their lived realities and political aspirations are at the core of the global discourse.



### **MISSION**

The **mission** of this conference is to create a **strategic and intellectual forum** that translates analysis into action. The discussions will be structured across three critical pillars:

- Legal Frameworks & Accountability How do international legal instruments, including the Genocide Convention, Rome Statute, and ICJ rulings, apply to the ongoing situation in Gaza? What obligations do states and institutions hold in preventing and prosecuting acts of genocide?
- Media, Testimonies & Advocacy How is the crisis in Gaza represented and misrepresented in global media? What role does journalism play in shaping public consciousness and countering disinformation?
- International Solidarity & Political Mobilization
  How can international movements, civil society, and diplomatic channels be leveraged to push for tangible political consequences against those complicit in war crimes and genocide?

This conference will serve as a catalyst for new coalitions and campaigns, ensuring that the pursuit of justice for Palestinians moves beyond rhetoric to real-world consequences.

At its core, this gathering is not just an academic or policy exercise—it is a declaration that genocide will not be met with silence. It is an insistence that the world must listen, act, and **hold perpetrators accountable**.

Through rigorous discussion, compelling testimonies, and strategic planning, we hope to **equip participants with the knowledge, networks, and tools needed to take decisive action.** 

This is not a moment for passive reflection—this is a call to break the cycle of impunity and advance the cause of justice for Gaza and Palestine.

# ABOUT THE PALESTINIAN RETURN CENTRE

The Palestinian Return Centre (PRC) is a London-based advocacy and research organization dedicated to defending the rights of Palestinians, with a primary focus on the right of return for Palestinian refugees as enshrined in international law. Established in 1996, PRC works to ensure that Palestinian displacement remains a key issue on the international agenda by engaging policymakers, academics, diplomats, and civil society organizations worldwide.

PRC holds special consultative status with the United Nations Economic and Social Council (ECOSOC), enabling it to participate in UN forums and advocate directly for Palestinian rights within international institutions. PRC regularly engages with the UK and international parliaments, as well as the United Nations, providing expert briefings, hosting events, and submitting reports that highlight the status of Palestinian human rights and the need for justice and accountability.

Through its advocacy, diplomatic engagement, public campaigns, and educational initiatives, PRC works to challenge misinformation, promote historical truth, and amplify Palestinian voices in global discussions.
