



**Israeli Genocide in Gaza  
Situation Report (No. 35)  
on the Israeli Aggression on Gaza**  
Covers the period from 14<sup>th</sup> to 23<sup>rd</sup> April 2024

# Introduction

This report documents the genocide committed by the Israeli occupation in the Gaza Strip, covering the period from April 14 to April 23, 2024. It includes monitoring and documenting daily scenes, as well as detailing the political and humanitarian repercussions, and the material and human loss that the Gaza Strip is suffering due to the ongoing aggression and siege, especially in light of the restrictions imposed on the entry of aid into the region. Additionally, it addresses the repercussions of the aggression in the West Bank, where citizens have also faced assassination and arrest by Israeli occupation forces since October 7, 2023.

## 1. Daily Scenes:

■ Sunday, April 14, 2024



The Israeli occupation army continued to commit massacres throughout the Gaza Strip. On this day, several massacres were documented, resulting in 48 deaths and over 75 wounded by the evening. The ongoing genocide by the Israeli occupation in the Gaza Strip persisted.

The Ministry of Health in Gaza announced that as of Sunday morning, 43 deaths and 62 injuries had been documented in the Gaza Strip due to four massacres committed by the occupation army against civilians. This increased the total number of victims to 33,729 deaths and 76,371 wounded from October 7, 2023, to April 14, 2024.

On the 191st day of the genocide carried out by the occupation army, the daily scenes demonstrated the falsity of the occupation's claims regarding the existence of safe areas in the Gaza Strip. The land, air, and sea bombardments targeted various areas of the Strip, including the neighborhoods of Al-Zaytoun, Tel Al-Hawa, and Sheikh Ijlin in Gaza City; Al-Nuseirat camp; Al-Mughraqa; Madinat Al-Zahra; and Deir al-Balah in the central region. Additionally, Bani Suhaila, Khan Yunis, and Abasan in the south, and Beit Hanoun in the north were also affected.

On Sunday, April 14, 2024, casualties continued to occur due to the restrictions imposed on the delivery and distribution of aid. The death of a child and injuries to other citizens were documented as aid boxes fell randomly on areas in the north and center of the Gaza Strip. In another incident, three children were injured while trying to retrieve aid that had fallen into the sea west of Deir al-Balah.



The occupation army also continued to commit war crimes against civilians and enforced forced displacement. One documented incident involved the targeting of a group of citizens who tried to return to their homes in the northern Gaza Strip, resulting in the death of a woman and injuries to 27 others. Additionally, the occupation army continued to target displaced people who sought refuge in schools, as evidenced by the death of a child in the "Abu Araban" school in the central Gaza Strip.

## Monday, April 15, 2024

On Monday, April 15, 2024, the Israeli occupation army continued to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 70 deaths and approximately 100 wounded by the evening, highlighting the ongoing genocide. The Ministry of Health in Gaza reported 68 deaths and 94 injuries as of Monday morning due to seven massacres committed by the occupation army against civilians in the Strip. This brought the total number of victims to 33,797 deaths and 76,465 wounded from October 7, 2023, to April 15, 2024.

On the 192nd day of the genocide, daily scenes demonstrated the falsity of the occupation's claims regarding the existence of safe areas in the Gaza Strip. The bombardment from land, air, and sea targeted various areas of the Strip, including Gaza City, Jabalia, Beit Hanoun, and Beit Lahia in the north, Rafah and Khan Yunis in the south, and the Al-Zawaida area, Al-Nuseirat camp, and Al-Maghazi camp in the central region.

On Monday, the occupation forces continued to prevent citizens from returning to their homes in the northern Gaza Strip, forcing hundreds to relocate to the south. The death of a child was documented as a result of the occupation army targeting citizens, part of a broader strategy to impose forced displacement on Gaza's residents.

In continuation of war crimes and crimes against humanity, it was documented that the bodies of at least 10 deaths, including women, were found in a mass grave near the Al-Shifa Medical Complex. The occupation army had executed these individuals and attempted to conceal their bodies by burying them randomly.

In the West Bank, the occupation forces persisted in their policy of systematic killing. The assassination of three citizens was documented in the Nablus Governorate, with two killed by settlers' bullets. This increased the number of victims in the West Bank to 470 deaths and 4,750 wounded from October 7, 2023, to April 15, 2024.

## **Tuesday, April 16, 2024**

On Tuesday, April 16, 2024, the Israeli occupation army continued to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 62 deaths and approximately 120 wounded by the evening, highlighting the ongoing genocide committed by the Israeli occupation in the Gaza Strip. The Ministry of Health in Gaza reported 46 deaths and 110 injuries as of Tuesday morning due to five



massacres committed by the occupation army against civilians. This brought the total number of victims to 33,843 deaths and 76,575 wounded from October 7, 2023, to April 16, 2024.

On the 193rd day of the genocide, daily scenes demonstrated the falsity of the occupation's claims regarding the existence of safe areas in the Gaza Strip. The bombardment from land, air, and sea targeted various areas of the Strip, including Gaza City, Rafah, and Khan Yunis in the south, Al-Nuseirat camp and Deir al-Balah in the center, and Jabalia, Beit Hanoun, and Beit Lahia in the north.

Regarding the continued attempts at forced displacement and targeting of the displaced, it was documented that the occupation forces forced women and children to flee from Beit Hanoun in the northern Gaza Strip after besieging shelter centers in the town, where they detained and abused young men. It was also documented that several schools housing hundreds of displaced people were besieged in Beit Hanoun amid violent artillery shelling.



On Tuesday, April 16, 2024, several testimonies were documented from Palestinian prisoners released from prisons and interrogation centers affiliated with the occupation army, including children as young as twelve years old. These testimonies

confirmed their exposure to various methods of torture, ill-treatment, and deprivation of healthcare, which caused severe health complications for many, including limb amputations.

### Wednesday, April 17, 2024

On Wednesday, April 17, 2024, the Israeli occupation army continued to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 64 deaths and 89 wounded by the evening, underscoring the ongoing genocide committed by the Israeli occupation in the Gaza Strip. The Ministry of Health in Gaza reported 56 deaths and 89 injuries as of Wednesday morning due to six massacres committed by the occupation army against civilians. This increased the total number of victims to 33,899 deaths and 76,664 wounded from October 7, 2023, to April 17, 2024.



On the 194th day of the genocide, daily scenes demonstrated the falsity of the occupation's claims regarding the existence of safe areas in the Gaza Strip. The bombardment from land, air, and sea targeted various areas of the Strip, including Al-Sheikh Redwan Market, Al-Zaytoun and Al-Shuja'iya neighborhoods, and Al-Shati Camp in Gaza City. In the central Gaza Strip,



the occupation army targeted the Al-Nuseirat camp, bombing and destroying it. In the south, inhabited homes were targeted in Rafah.

In the northern Gaza Strip, occupation forces were observed retreating into the town of Beit Hanoun, where they besieged hundreds of displaced people in the “Mahdiya al-Shawa” school after arresting an unspecified number of them.

## Thursday, April 18, 2024

On Thursday, April 18, 2024, the Israeli occupation army continued to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 76 deaths and 106 wounded by the evening, highlighting the ongoing genocide committed by the Israeli occupation in the Gaza Strip. The Ministry of Health in Gaza reported 71 deaths and 106 injuries as of Thursday morning due to seven massacres committed by the occupation army against civilians. This brought the total number of victims to 33,970 deaths and 76,770 wounded from October 7, 2023, to April 18, 2024. On the 195th day of the genocide, daily scenes demonstrated the falsity of the occupation’s claims regarding the existence of safe areas in the Gaza Strip.



The bombardment from land, air, and sea targeted various areas of the Strip, including the Sheikh Ijlin area, the neighborhoods of Tel Al-Hawa and Al-Zaytoun, and the Al-Shati camp in Gaza City. In the central Gaza Strip, Al-Nuseirat camp and Deir al-Balah were targeted, while in the south, Khan Yunis and Rafah were bombarded.

Regarding the crime of enforced disappearance committed by the occupation army, the deaths of citizens from the Gaza Strip was documented while they were forcibly taken for investigation into the territories occupied in 1948, without specifying the location of the prison or investigation center where the assassination occurred. Additionally, in an effort to prevent service institutions from performing their duties or providing civil and humanitarian services to citizens, the occupation army bombed the headquarters of the Wadi Al-Salqa municipality, leading to its complete destruction.

## Friday, April 19, 2024

On Friday, April 19, 2024, the Israeli occupation army continued to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 44 deaths and 63 wounded by the evening, underscoring the ongoing genocide committed by the Israeli occupation in the Gaza Strip. The Ministry of Health in Gaza reported 42 deaths and 63 injuries as of Friday morning due to four massacres committed by the occupation army against civilians. This brought the total number of victims to 34,012 deaths and 76,833 wounded from October 7, 2023, to April 19, 2024.

On the 196th day of the genocide, daily scenes demonstrated the falsity of the occupation's claims regarding the existence of safe areas in the Gaza Strip. The bombardment from land, air, and sea targeted various areas of the Strip, including the Sheikh Radwan neighborhood and the Al-Shati Camp in Gaza City, Rafah in the south, and Beit Lahia and Jabalia camp in the north of the Gaza Strip.



Additionally, about 30 deaths were recovered from two mass graves in the courtyard of the Al-Shifa Medical Complex in Gaza City, including the bodies of women and the elderly. There are also 1,000 missing persons being monitored as a result of the aggression launched by the occupation army against the complex in March 2024, which lasted for two weeks.

In the West Bank, the occupation forces continued their policy of systematic killing. The assassination of a Palestinian child from Tulkarm camp was documented after he was hit by live bullets during an incursion by the occupation forces into the camp. This increased the number of victims in the West Bank to 471 deaths and 4,750 wounded from October 7, 2023, to April 19, 2024.

## ■ Saturday, April 20, 2024

On Saturday, April 20, 2024, the Israeli occupation army continued to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 42 deaths and 68 wounded by the evening, underscoring the ongoing genocide committed by the Israeli occupation in the Gaza Strip. The Ministry of Health in Gaza reported 37 deaths and 68 injuries as of Saturday morning due to four massacres committed by the occupation army against civilians. This brought the total number of victims to 34,049 deaths and 76,901 wounded from October 7, 2023, to April 20, 2024.

On the 197th day of the genocide, Daily scenes demonstrated the falsity of the occupation's claims regarding the existence of safe areas in the Gaza Strip. The bombardment from land, air, and sea targeted various areas of the Strip, including Rafah, the Al-Mawasi area, and Khan Yunis in the south, Al-Nuseirat camp and the Al-Mughraqa area in the central region, and the Jabal al-Rais area and the vicinity of Al-Karama Hospital in Gaza City.

Regarding the continued targeting of the displaced and attempts to impose forced displacement, a direct bombardment of displaced persons' tents in the west of Khan Yunis Governorate was documented, resulting in two deaths and an unspecified number of wounded. Additionally, significant damage was observed to the displaced people's tents due to the bombing of a house in Al-Mawasi area of Khan Yunis, in the southern Gaza Strip.

In the West Bank, the occupation forces continued their policy of systematic killing. The assassination of 14 Palestinian citizens from the Tulkarm camp was documented as a result of a comprehensive aggression launched by the occupation army against

the camp, committing a massacre against the citizens. This increased the number of victims in the West Bank to 485 deaths and 4,800 wounded from October 7, 2023, to April 20, 2024.

## ■ Sunday, April 21, 2024

Sunday, April 21, 2024, saw the Israeli occupation army continue to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 55 deaths and 85 wounded by the evening, underscoring the ongoing genocide committed by the Israeli occupation in the Gaza Strip. The Ministry of Health in Gaza reported 48 deaths and



79 injuries as of Sunday morning due to five massacres committed by the occupation army against civilians. This brought the total number of victims to 34,097 deaths and 76,980 wounded from October 7, 2023, to April 21, 2024.

On the 198th day of the genocide, daily scenes further disproved the occupation's claims regarding the existence of safe areas in the Gaza Strip. The ground, air, and sea bombardment targeted various areas of the Strip, including Al-Shati camp in Gaza City, the Bureij camp, and the Al-Mughraqa area in the central region, as well as Rafah and Khan Yunis in the south.

Regarding the targeting of displaced people and the ongoing attempts to impose forced displacement, it was documented that the tents of displaced people were targeted in the Al-Mawasi area in the south of the Gaza Strip, resulting in two deaths and an unspecified number of other citizens being injured. Additionally, massacres that claimed the lives of large numbers of displaced people were documented following the discovery of two mass graves inside the Nasser Medical Complex in Khan Yunis.

In the West Bank, the occupation forces continued their policy of systematic killing. The assassination of three Palestinian citizens, including a woman, in Tubas, and two other young men in Hebron, was documented after they were directly targeted with live bullets. This increased the number of victims in the West Bank that day to 488 deaths and 4,800 wounded from October 7, 2023, to April 21, 2024.



## Monday, April 22, 2024

Monday, April 22, 2024, witnessed the Israeli occupation army continues to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 60 deaths and 115 wounded by the evening, highlighting the ongoing genocide committed by the Israeli occupation in the Gaza Strip. The Ministry of Health in Gaza reported 54 deaths and 104

injuries as of Monday morning due to six massacres committed by the occupation army against civilians. This brought the total number of victims to 34,151 deaths and 77,084 wounded from October 7, 2023, to April 22, 2024.

On the 199th day of the genocide, daily scenes further exposed the falsity of the occupation's claims regarding the existence of safe areas in the Gaza Strip. The land, air, and sea bombardment targeted various areas of the



Strip, including the Al-Zaytoun and Al-Tuffah neighborhoods in Gaza City, Bureij, Al-Nuseirat, and Deir al-Balah camps in the central region, and Rafah and Khan Yunis in the south.

Regarding the continued revelation of the crimes and massacres of the occupation army, it was documented that the bodies of 73 deaths were recovered from a mass grave in the Nasser Medical Complex in Khan Yunis. The victims included the sick and wounded, doctors, and displaced people who were present in the complex and its surroundings. Additionally, several cases of forced disappearance to which those present in the complex were subjected were documented, further highlighting the atrocities committed by the occupation forces.

## ■ Tuesday, April 23, 2024



Tuesday, April 23, 2024, saw the Israeli occupation army continue to commit massacres throughout the Gaza Strip. Several massacres were documented, resulting in 36 deaths and 59 wounded by the evening, further emphasizing the ongoing genocide committed by the Israeli occupation in the Gaza Strip.

The Ministry of Health in Gaza reported 32 deaths and 59 injuries as of Tuesday morning due to three massacres committed by the occupation army against civilians. This brought the total number

of victims to 34,183 deaths and 77,143 wounded from October 7, 2023, to April 23, 2024. On the 200th day of the genocide, daily scenes once again invalidated the occupation's claims regarding the existence of safe areas in the Gaza Strip. The land, air, and sea bombardment targeted various areas of the Strip, including Al-Shuja'iya and Tel al-Hawa neighborhoods in Gaza City, Al-Zawaida, Deir al-Balah, Al-Mughraqa, Al-Nuseirat, and Madinat Al-Zahra in the central region, as well as Khan Yunis and Rafah in the south and Beit Lahia in the north. Regarding the issue of displacement, a new wave of displacement of hundreds of families from Jabalia in the northern Gaza Strip to Gaza City and the Jabalia and Al-Shati camps was documented. This followed severe and violent attacks targeting



homes and citizens. The occupation army also continued to target the displaced, as the death of a citizen and the injury of others were documented in the Beit Lahia stadium in the northern Gaza Strip.

In the West Bank, the occupation forces persisted in their policy of systematic killing. The assassination of a Palestinian citizen was documented by the bullets of occupation soldiers in the Jericho Governorate. This increased the number of victims in the West Bank on that day to 489 deaths and 4,800 wounded from October 7, 2023, to April 23, 2024.

## 2. Political and Humanitarian Repercussions:

In terms of humanitarian repercussions, Rafah faced extremely difficult living conditions due to severe fears that exacerbated the already catastrophic humanitarian situation, especially in light of the continued threat of invasion by the occupation army. After 7 months of war on the Gaza Strip, the health system was destroyed, leaving only 3 hospitals providing maternity care services throughout Gaza, despite an estimated 180 daily births.



UNRWA reported that since November 2023, about 12,340 tons of cooking gas, with a daily average of 82 tons, had entered Gaza. This represents a 68% decrease compared to the daily average in the first nine months of 2023, contributing to severe shortages of food, supplies, and famine throughout the Strip.

Regarding international reactions to the occupation authorities' use of artificial intelligence to conduct crimes in the Gaza Strip, United Nations experts denounced its military applications, which resulted in unprecedented losses in civilian populations, housing, vital services, and infrastructure. Suspicions arose concerning the use of artificial intelligence systems such as "Gospel," "Lavender," and "Where's Daddy."

In terms of political repercussions, an investigation issued during the report's covered period confirmed the neutrality of UNRWA despite unproven accusations against the agency regarding the participation of its employees in Operation Al-Aqsa Flood. Notably, United Nations institutions, including UNRWA, suffered human and material losses, including the death of 208 employees and damage to over 160 UNRWA facilities, as per the latest update during the report's covered period.

### **3. Human Loss and Material Damage:**

The number of deaths in the Gaza Strip from October 7, 2023, to April 23, 2024, reached 34,183, including 14,778 children, among whom 30 children died because of famine. Additionally, 9,752 women, 485 medical personnel, 67 civil defence

members, and 144 journalists were  
 The wounded numbered 77,143,  
 while 7,000 people remain missing, with  
 children and women comprising 70% of the  
 missing. The number of displaced people  
 has risen to 2 million. The occupation army  
 committed more than 3,025 massacres.



Regarding detainees from the Gaza Strip, 310 cases of arrests among medical personnel and 20 cases among journalists have been monitored and documented since the start of the ground invasion on October 27, 2023. The total number of arrests exceeded 5,000 cases as of April 23, 2024.

Infrastructure destruction includes the demolition of 181 government headquarters, rendering 103 schools and universities completely out of service, while 309 others suffered partial damage. Furthermore, 239 mosques were completely destroyed, and 317 were partially demolished by the occupation forces. Additionally, three churches were destroyed. In terms of residential units, 86,000 were completely demolished, and 294,000 were partially destroyed. The occupation also targeted 200 archaeological and heritage sites, resulting from the detonation of over 75,000 tons of explosives. As part of its war on hospitals, the occupation army targeted 32 hospitals, rendering them out of service, and also disabled 53 health centers.

Additionally, 160 health institutions were subjected to attacks and strikes, affecting the provision of health services, while 126 ambulances were targeted and completely damaged.

The repercussions of this targeting and the prevention of necessary aid and medicines include the deterioration of the health condition of Palestinian citizens. Documented cases include 1,090,000 instances of infectious diseases, 8,000 cases of viral hepatitis, 10,000 cases of untreated cancer, 60,000 pregnant women without access to healthcare, and 350,000 cases of chronic diseases.

In the West Bank, the number of victims reached 489

martyrs, with over 4,800 wounded and 8,088 individuals taken captive. The forced displacement process in the West Bank has affected approximately 3,985 people, with about 648 facilities demolished. These numbers depict the repercussions of the genocide committed by the Israeli occupation in the Gaza Strip from October 7, 2023, to April 23, 2024.
